### Purposes for which Personal Data is Processed

Your information is confidential and will not be disclosed to any third party without your consent except as described here. Legally enforceable obligations include Deutsche Bank entering into a contract with the receiving organisation, strict compliance with Deutsche Bank's internal policies, and taking all other steps that may be required under the laws in those countries and territories.

### Retention

Deutsche Bank may store your information according to applicable (taxation, regulatory, etc.) laws. We will cease to retain your personal data once there is no longer any legal or business purpose for retaining your personal data.
