

SINGAPORE PERSONAL DATA PROTECTION ACT 2012 PERSONAL DATA ACCESS & CORRECTION REQUEST FORM

Important Notice to Requestor

- 1. Please read this notice carefully before completing this form. Where this form contains a summary of the relevant requirements under the Singapore Personal Data Protection Act 2012 ("the PDPA"), the summary is provided for reference purpose only. Please refer to the PDPA, its regulations and guidelines for full details.
- 2. The information requested for in this form is to enable Deutsche Bank to respond more expeditiously to your request but may not be exhaustive. Deutsche Bank may require additional information and/or verification in order to respond to your request.
- 3. To make a request for access to or correction of personal data under the PDPA, you must be the individual to which the personal data relates, the legal representative or the legal guardian(s) or parent(s) of an incapacitated individual.
- 4. Deutsche Bank is entitled to adopt appropriate measures to verify that you are the individual to which the personal data relates or that you are validly acting on behalf of the individual.
- 5. You may only request for personal data that is in the possession or under the control of Deutsche Bank which has been or may have been used or disclosed by Deutsche Bank within a year before the date of your request. Deutsche Bank is not required to provide information on the source of your personal data.
- 6. The data that Deustche Bank is not obliged to provide includes the following:
 - a. opinion data kept solely for an evaluative purpose;
 - b. the personal data of the beneficiaries of a private trust kept solely for the purpose of administering the trust;
 - c. a document related to a prosecution if all proceedings related to the prosecution have not yet been completed;
 - d. personal data which is subject to legal privilege;
 - e. personal data which, if disclosed, would reveal confidential commercial information that could, in the opinion of a reasonable person, harm the competitive position of Deutsche Bank;
 - f. personal data collected, used or disclosed without consent for the purposes of an investigation if the investigation and associated proceedings and appeals have not been completed; or
 - g. any request:
 - that would unreasonably interfere with our operations because of the repetitious or systematic nature of the requests;
 - ii. if the burden or expense of providing access would be unreasonable to Deutsche Bank or disproportionate to your interests;
 - iii. for information that does not exist or cannot be found;
 - iv. for information that is trivial; or
 - v. that is otherwise frivolous or vexatious.
- 7. Deutsche Bank will also not provide personal data or other information which could reasonably be expected to:
 - a. threaten the safety or physical or mental health of any other individual;
 - b. cause immediate or grave harm to your safety or physical or mental health;
 - c. reveal personal data about another individual;
 - d. reveal the identity of an individual who has provided personal data about another individual and the individual providing the personal data does not consent to the disclosure of his identity; or
 - e. be contrary to national interest.
- 8. Deutsche Bank may charge a reasonable fee for access to your personal data. Such fee may vary depending on the complexity of your request. We will give you a written estimate of your fee after we have obtained sufficient information to estimate the fee and may refuse to provide access to your personal data until you agree to pay the relevant fee. If the fee is higher than the original written estimate, we will inform you in writing of the increased fee.

- 9. On receipt of a correction request, Deutsche Bank will, unless it is satisfied on reasonable grounds that the correction should not be made:
 - a. correct the personal data as soon as practicable; and
 - b. send the corrected personal data to every other organisation to which the personal data was disclosed by Deutsche Bank within a year before the date the correction request was made, unless that other organisation does not need the corrected personal data for any legal or business purpose.
- 10. In relation to a correction request, Deutsche Bank is not required to correct or otherwise alter an opinion including a professional or an expert opinion. Deutsche Bank is also not required to make a correction in respect of matters including the following:
 - a. opinion data kept solely for an evaluative purpose;
 - b. the personal data of the beneficiaries of a private trust kept solely for the purpose of administering the trust;
 - c. a document related to a prosecution if all proceedings related to the prosecution have not been completed.
- 11. Deutsche Bank will respond to an access or correction request within 30 days. If Deutsche Bank is unable to respond to an access or correction request within this timeframe, we will inform you in writing within that time frame of the time by which we will be able to respond to your request.
